### **Executive Committee Report**

#### **2017 ASRT Annual Conference and House of Delegates**

June 24-25, 2017

Orlando, Florida

Tammy Delker and Don Bishop attended the 2017 ASRT Annual Conference in Orlando, Florida. Other attendees representing Iowa were, Darin Delker, Shelly Pike and two radiology students.

## Day One

The first HOD Business meeting was called to order by Mike Odgren – ASRT speaker of the House. The ceremony was started off by presentation of the flags, which were carried by the 94 students. Included for the first time was student representation from the Military chapter and Puerto Rico. Presentation of the colors and singing of the national anthem was done. Beth Weber Vice speaker of the house reported that there were 158 seated delegates present at the meeting.

Definitions and rules were given and a short video was shown on how to click and vote. The house voted to adopt the credentials report, the house of delegate rules and the agenda as printed. Beth Weber presented the Memorial Resolutions and was adopted as presented.

ASRT Annual Report- was given by Mike Latimer, President of the ASRT. Mike spoke about the VA Bill and the hard work it took from

all of the members to stop the bill and stated this fight is not over and be diligent. Mike spoke of the importance of developing leaders at the affiliate level and stated that the Online Advocate Academy was in its final stages and will be rolled out sometime in the fall. This will be a 10 week course available to help the affiliate leaders. Mike also spoke about the increase in student involvement and the Radiography standard exam preparation development that is available for students; there are 5 practice exams with regular membership with an additional 2 for premium members.

The ASRT educators institute will be a toolkit that is used by educators to help with student development. The course outline has been completed and the next step is to select authors and speakers. This will be announced at a later date and time as to when the roll out will happen.

Awards- The annual drawing contest raised more than \$53,000 with the most tickets being sold 1<sup>st</sup> place Ohio and 2<sup>nd</sup> place New Jersey. Most money raised per capita 1<sup>st</sup> place went to Alaska and 2<sup>nd</sup> place



to Minnesota. The outstanding grass roots awards for individuals went to Patricia Willett from Massachusetts and Brandy Cusson from New Hampshire. The Affiliate grass roots award winners were the Kentucky Society and the New Hampshire Society of Radiologic Technologist. The Most active chapter awards were given out with 1<sup>st</sup> place being tied between Computed Tomography and the Registered Radiologic Assistant chapters. 2<sup>nd</sup> place was the education chapter and 3<sup>rd</sup> Bone densitometry.

ASRT Update- was given by Sal Martino, CEO of the ASRT. The ASRT has 153,000 members with 118 staff members, of those staff 20% are current RT's and the executive board is made up of 50% RT's. With an operating budget of 25 million dollars. Currently the ASRT has 92 out of 153,000 members that are fellows, that is 0.06% and it is a very distinct honor. Sal spoke on the value of membership and member services, and the importance to prove that the ASRT has value to their members besides being a CEU provider. Sal stressed the advocacy of our profession as well as the growing need for us to all stand united. A short video titled "Working for you was

shown and will be added to the ASRT website and social media platforms. It was stated that we provide CEU's for our members but are not a CEU provider in the sense of doing only that, so we cannot be competitive with CEU sites, we advocate for our members they don't

One year after New Hampshire licensure passed the ASRT and local affiliates had to defend against a bill to remove licensure. The fight against deregulation is huge at this current time. In West Virginia there has been a licensure bill for over 40 years and recently had a bill introduced to do away with licensure.

Sal spoke of the need to support one another even if not our primary modality. The MARCA bill was briefly discussed with computers being set up at various locations for members to send letters to representatives about the bill.

President Elect Amanda Garlock spoke and presented her presidential initiatives for the upcoming year ,which include career

tools for members, MR best practices, and adopting a “ Power of A” campaign.

AFFILIATE OPEN FORUM- Dana Aragon spoke about affiliate compliance and that it has been around now for 10 years. Reminded affiliates that compliance is due within 60 days of the end of your fiscal year. Also that the majority of stated have done away with subordinates. For the affiliates to be in compliance the ASRT needs a copy of their bylaws and a signed chapter agreement. Dana spoke that the ASRT is a 501 C6 – rather than a C3 because a C3 can’t legally lobby.

ARRT UPDATE- starting January 1, 2018 structured post-primary certification will need to meet minimum requirements of 16 hours. Ethic violations must be self-reported within 30 days and if you have questions look at the rules of ethics on the website and make sure you understand them. The Continued Qualification Requirements (CQR) were discussed and if not completed by those individual required to take it the ARRT will terminate those credentials. It was

stressed that this not a retaking of boards and cannot be passed or failed, it just identifies a gap in knowledge. The CQR is done in 3 parts 1<sup>st</sup> do the profile, 2<sup>nd</sup> do the assessment, 3<sup>rd</sup> complete the recommendations of CEU's to fill the gaps. If no gaps are found then you can choose any CEU's to fulfill your biennium requirement.

JCERT UPDATE- was very brief and to the point, standard revisions draft will be out in late fall 2017 and JCERT are looking for site visitors, if interested go to their website. No other discussion.

Day 2

BY-LAWS OPEN FORUM and COMMISSIONS HEARING- by-laws were discussed and 4 motions were pulled from the consent calendar

SPEAKER and VICE SPEAKER open forum- there was one nomination for speaker of the house, Beth Weber the current vice speaker of the house. The vice speaker had four nominations.

Questions were presented to all the candidates for vice speaker of the house. The forum was then closed for vote later.

I attended the Cardiac Interventional and Vascular Interventional chapter meeting. Elections for the new chair and vice chair were held and questions were taken from members in attendance. This meeting was very uneventful considering the chapter had its bylaw changes last year. The ever increasing encroachment of RCIS certification over primary certification was discussed and advocacy is the answer. RCIS certified members can be a member of our chapter and be a voting member if they 1<sup>st</sup> have a primary certification, the ASRT only recognizes RCIS as a secondary certification. Physiological stress in our field was also discussed and how to deal with the high stress and demand of this fields as well on how to deal with poor patient outcomes.

I also attended the Radiology chapter meeting where introduction of the current delegates and alternate delegates and the practice

standards committee members took place. Ballots were handed out for the voting of a chair and vice chair for the 2017-2018 year. Starting next year, 2018, voting for the chair and vice chair will change. Whoever gets the most votes in the national election will be chair and 2<sup>nd</sup> most votes will be vice chair. Kevin Rush from the ARRT went over the changes that were discussed earlier in this report. An emotional debate took place for the ARRT looking into changing the entry level requirements to sit for boards from an AS degree to a BS degree took place with no resolution. Kevin stated that at this time it was just something that was being discussed.

### DAY 3

HOD BUISNESS MEETING- was called to order by Mike Odgren. Beth Weber presented the credentials report 159 delegates present; one delegate had been seated since the prior meeting. The credential report was passed and quorum met.

Dawn Moore presented the By-laws report with all by-law amendments becoming effective at the close of the business meeting unless a specific date was adopted.

Joe Whitten presented the consent calendar and was passed with the exception of the pulled numbers 17.06, 17.12, 17.13, 17.14 and 17.49.

Voting for the remainder of the HOD meeting was changed from electronic to visual voting cards as there was a technical glitch that could not be resolved.

No late motions were presented. Election results for speaker and vice speaker were as follows: Speaker of the House Beth Webber and Vice Speaker of the House Joe Whitten.

## SCIENTIFIC POSTER RULES

### 1. ELIGIBILITY

A. There is one category of scientific poster competition.

1. Registered radiographers and Student radiographers shall compete in one category and may have only one entry.
2. These categories shall be judged separately and all shall receive equivalent awards.

B. All members in good standing of the Iowa Society of Radiologic Technologists, except those described in paragraph C below, are eligible to compete, provided that their completed applications are sent to the I.S.R.T. President-Elect postmarked no later than **January 15th**, of the current year. (See Section III paragraph A)

C. The following I.S.R.T members may NOT participate in competition:

1. President
2. President-Elect
3. Annual Meeting General Chairman
4. Co-Chairman
5. Scientific Exhibit Judges
6. Persons employed by commercial firms engaged in the sale, repair or manufacture of imaging equipment or products.

D. Once the poster is submitted for competition it may not be entered in subsequent I.S.R.T annual meeting competitions.

E. In order to be eligible for competition the participant(s) must be a member(s) of the I.S.R.T at the time of submission. The competitor(s) must send a copy of their current I.S.R.T. membership card in with the application for presentation.

## **II. JUDGING**

- A. Judges shall be appointed by the President-Elect. The Executive Committee of the I.S.R.T shall approve their selection. Judges shall be responsible only to the President-Elect. Judges must inform the President-Elect of any actual or potential conflicts of interests encountered while serving as a judge.
- B. The judges' selection of award winners shall be based upon the ratings listed in the SCIENTIFIC POSTER EVALUATION {Section VI}. The decisions of the judges are final.
- C. The scientific poster judges shall complete a written evaluation of each scientific poster, and the evaluation shall be available to each participant upon request. The request by each primary participant shall be made on the application form.

## **III. POSTERS**

- A. Applications are to be sent to the I.S.R.T President-Elect by certified mail, return receipt requested. Submission date is determined by the postmark and the returned receipt verifies and acknowledges receipt by the President-Elect.
- B. After submission of the application to the President-Elect, NO CHANGES may be made with regard to poster title or primary participant.

C. A maximum of two authors per scientific poster shall be allowed.

D. Poster Format

1. A participant will share **a six foot table 15” deep** to display a self-contained poster.
2. View boxes **WILL NOT** be permitted
3. Posters that do not conform to the specifications mentioned in the above paragraph shall **NOT** be eligible for competition.

F. Posters must represent the original work of the participant(s) and cannot be commercially prepared. The posters shall not contain any marks or clues to the participant’s identity such as pictures, references to physicians, hospitals or companies; address; or telephone number. The poster shall demonstrate, in the lower right hand corner, an ID supplied by the I.S.R.T., (no larger than 3”x5”) containing four digits. The President-Elect will prepare the four digit ID card.

G. The poster must be self-explanatory. Appropriate media may support it. It shall be limited to a subject area related to the Imaging Sciences. Posters shall not contain excessive written descriptive explanation. A well-presented exhibit requires only minimum written explanation. The poster shall speak for itself.

H. If visuals are incorporated, no identification of a patient or his or her name is permitted.

I. A scientific poster submitted for competition must not have been previously shown at an I.S.R.T. Annual Meeting. A scientific poster, having been shown competitively at any other Radiologic meeting (A.S.R.T, other affiliate societies, etc.) may be submitted for competition.

J. Any poster that does not adhere strictly to these rules will be eliminated from competition. **No exceptions will be made to these rules.**

#### **IV. INSTALLATION AND DISMANTLING OF POSTERS**

##### A. Installation:

1. The Posters Committee will assign display space.
2. Each participant will assume responsibility for arranging his/her poster consistent with the directions of the Posters Committee.
3. If a participant is unable to install and/or dismantle his/her poster, he/she shall personally arrange for a designee to assume this responsibility.
4. Installation of scientific posters should begin on Friday, the first day of the annual meeting at 7:00 A.M. and must be completed by 1:00 P.M. Friday.

##### B. Dismantling:

1. Scientific posters shall remain intact in the viewing areas until 12:00 Noon, Saturday, the last day of the annual meeting. At which time award checks will be available through the Executive Secretary.
2. Scientific posters shall be dismantled no later than 2:00 P.M. Saturday, the last day of the annual meeting.
3. Scientific posters that are not dismantled by the specified time shall be disposed off at the I.S.R.T.'s discretion.

## **V. LIABILITY**

A. The participant(s) shall assume responsibility for the poster.

B. The I.S.R.T. is not responsible for loss or damage. All reasonable precautions to assure safety of the posters during the viewing periods specified in the official annual meeting program will be exercised by the participant.

## **VI. SCIENTIFIC POSTER JUDGING CRITERIA**

All posters shall be judged by the criteria and point scale of the SCIENTIFIC POSTER EVALUATION.
